

### PRIVACY POLICY

**Why?** Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

**What?** The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and date of birth
- Account balances and payment history
- Credit history and credit scores
- Income and assets

**How?** All financial companies need to share customers' personal information to run their everyday business. - sharing for nonaffiliates to market to you

Additionally, when you are no longer our customer, we continue to share your information as described in this notice.

State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.

### Definitions:

<b>Affiliates</b>	Companies related by common ownership or control. They can be financial and nonfinancial companies. ReverseMortgages.com has no affiliates.
<b>Nonaffiliates</b>	Companies not related by common ownership or control. They can be financial and nonfinancial companies.
<b>Joint Marketing</b>	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. ReverseMortgages.com does not jointly market.
